Proof of Membership: If Individuals competing are also part of a competing Team, Team Registration will be sufficient for proof of USAWS Membership. If Individuals qualified via a Regional Tournament, the proof of Membership was established at the Regional Tournament. If there are any different drivers, riders, skiers (Team Jump), etc. from the Regional Tournament, they will be responsible for providing proof of USAWS Membership at Registration. If Individuals did not qualify through a Regional tournament, they will be required to show proof of USAWS Membership at Registration.

No Music Lists will be required for Individual Events competition.
